# SELCo TARIFFS - APPENDIX

## Rules and Conditions Applicable to the Tariffs valid from July 2016

The following rules and conditions are part of the approved tariffs of SELCo:

- SELCO will apply time-of-use (TOU) tariffs to customers as approved by the ECB.
- Time-of-use tariffs will be implemented on a mandatory basis where SELCo has deployed its new metering capability catering for same.
- There will be no conversion fee payable to migrate from Standard Rate to Time of Use rates as migration is mandatory.
- TOU timeslots are as follows (O = off-peak, S = Standard, P = Peak):

High season is 1 June through 31 August, low season is the rest of the year.

- Any mass place of worship with a single or three phase connection up to 60A that is not in continuous daily use will qualify for the Religious Tariff Set, where basic service charges have been reduced by 35%. Energy tariffs will remain unchanged.
- The Maximum Demand charge shall be the highest maximum demand registered in the month.
- The Network Access charge shall be based on the Notified Maximum Demand if the actual metered Maximum Demand is lower. In the absence of same being specifically applied for by the customer, the Network Access Charge shall be the highest maximum demand registered over the preceding 12 month period.
- Maximum demand and network access charges shall be levied at the maximum demand registered on the meter regardless of time registered. For the avoidance of doubt, Maximum demand and network access metering will take place during peak, standard and off-peak times.
